#### **Payments Platform Migration**

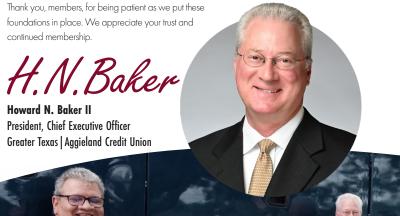

#### PROTECT YOURSELF FROM FRAUD (CONTINUED)

- Intellectual Property Risks: Sharing proprietary information within an open-source platform could result in unintended disclosure or even loss of competitive advantage.
- 3. Personal Security: Personal information such as addresses, phone numbers, or any other identifiable data should never be shared on platforms like ChatGPT to prevent risks such as identity theft or unwanted contact.

#### **BEST PRACTICES FOR SAFE USE**

- Anonymize Your Interactions: When interacting with ChatGPT, ensure
  that you do not use real names or identifiable details. Use pseudonyms if
  necessary to maintain anonymity.
- 2. Avoid Sensitive Topics: Steer clear from discussing topics that involve confidential business strategies or personal issues that require discretion.
- Regularly Review Permissions: If you are integrating ChatGPT into applications or systems, regularly audit permissions to ensure that only necessary access is granted.
- 4. Educate Users: For organizations implementing ChatGPT for team use, conduct training sessions on data privacy best practices to ensure everyone understands the importance of protecting sensitive information.
- Monitor Usage: Keep track of how ChatGPT is used within your organization or personal projects to identify any potential risks early on.
